- 9 have been accepted
- 3 are accepted but submitted by IGB (prop 2 & 4& 5 booklet)
- 7 proposals are rejected as similar to accepted proposals
- 9 proposals can be changed by admin and do not need a proposal
- Some of France are changes of Handbook
- Others are refused

Convention 2024.**
