Dear Inner Wheel friends of Europe

15 years ago, the necessity to create an Inner Wheel annual meeting become of a real importance.

It was first decided, by our friend from Italy, Luisa Vinciguerra who since she join IW, is one of the most brilliant brains behind many of our projects, and the European meeting who was proposed by her in Torino in 2005, followed the next year by France.

During many years we met once a year, in a different European country, trying to determine what should be improved in our organization and its functioning.

Step by step the work and the reflection became more intensive with real themes worked out each year. In Patras we decided that all European countries should work during the year about IW management, training, and constitution issues, that Inner Wheel in Europe should become a laboratory to revitalize IIW, in order to develop some fresh thinking, original proposals, considering that our Constitution was almost obsolete.



Thanks to the restructuring of the European Meeting, approved in the 14° Edition of 2020, the first virtual one, organized by Greece, which includes a 3-year path, we were able to use digital methods, and transform the annual meeting into a series of meetings and workshops during the whole year.

But for 2021-2022, during the year of F.A.M.A.T. France organizing it, near 3 years before the Manchester Convention, where we will be celebrating our centennial, we took last October ALL TOGETHER IN OUR GROUP, one of the most important decision, to work on a new Constitution, more flexible, more adapted to the new millennium, to the requests of the younger members, and before all adapted to the biggest revolution we had seen since the discovery of the printing, I mean the digital revolution which invaded everything from economy to innovation, science, education, health and of course our lifestyle and governance.

The "Law area", already considered in 15° Edition by Italy, the first hybrid one, has been the focus of this 16° Edition by F.A.M.A.T. France.

Of course, at each Convention we made some changes, so we add, we add, but never really try to restructure it, adapt it to the new era, taking the constitution as a whole!

I must say that we had a real collaboration, working side by side, hand in hand, with our group of European leaders and experts and their clubs.

BUT we quickly realized that to make a new constitution in 7/8 months, was an impossible mission, so we decided to divide our statutes in 10 chapters organizing 10 workshops with some leaders at the head of each one, who worked with much attention...

First to determinate what where the most urgent changes, those we cannot avoid...

With a very careful attention on each phrase, each word, we removed, modified, replaced, or created an important part of what we think should rule our Association during the coming years.

We had a wonderful time doing that, the pleasure to do it together, it was a huge work, but we did it...... and we will be presenting 42 new proposals and several General motions for the centennial Convention, we really can be happy with our results...

Now, we need to hope that all IIW countries will agree and support our proposals, but first of all they have to get the agreement of our Constitution Chairmen and her Committee, an essential ordeal...!

In Melbourne Convention we were told that in Manchester we should have as less business sessions as possible and as much workshops and training courses we could afford?

But we also all have in mind that in Manchester we will celebrate our centennial and that we cannot solve our problems with the same thinking we used when we create our First Constitution in Dublin in 1934 and following triennial Conventions.

A NEW CONSTITUTION IS OUR FUTURE, we need it to survive, so I beg our international executives' members and more specially our Constitution chairman to pay attention to our requests and I am sure they will do it.

Thank you, my dear friends, for the work done together.

A very special thanks to Isabelle who besides the huge work she had in F.A.M.A.T. as secretary during the year of total F.A.M.A.T. reconstruction she took the time to prepare this important meeting with a real commitment, making sure that everything is in order.



My last hope is that those who will follow us will be worthy of their mission and will keep the same spirit, which was the one of our founder Margaret Golding, an exceptional visionary woman.

I was extremely proud to be part of this work, now it is in the hand of the younger generations, and I wish them to have as much joy and pleasure as I had during the time, I serve Inner Wheel and will serve it as long as I will be able to do it.

Thank you for listening to me.

Inner wheel is one of the largest women's service and voluntary Association

Inner Wheel is nonpolitical, nonsectarian, and not profitable organization

Inner Wheel members mission worldwide, is to give people better lives in a more sustainable World, promote Peace, Human Rights, and gender equality.

Inner Wheel fights against poverty as well as violence towards children and women

Inner Wheel works for a better education, better health assists with handicaps and diseases.

Inner Wheel was created in Manchester, GB & I by Margaret Golding on January 10th, 1924

Inner Wheel became International in 1967

Inner Wheel joined the UN, became an NGO inserted in the ECOSOC Roster in 1972

Inner Wheel has six representatives in UN, 2 in New York, 1 in Geneva and 3 in Vienna

MOTIVATION

It is vital to mention and explain what Inner Wheel exactly consists in, as it was not mentioned before in the Constitution itself.

It is vital for each member to know precisely what Inner Wheel is and does!

It is vital for a new member who joins IW to have in mind the fundamentals and the values of the Association.

It is vital for an Association to have a concrete mission, well defined and corresponding to the needs of the new millennium.

What defines IIW through the world, these last 100 years, is service, service, service ... It must definitively become our first object.

The second most striking aspect of IW is "kindness with mutual respect" as it is the best form of humanity, it is stronger than friendship, it is a state of enduring affection, esteem, trust, and confidence between members. Respect means that you accept somebody for what she is, even if she is different from you, or you don't agree with her. Respect builds feeling of trust, safety, and wellbeing

In third: INTERNATIONAL UNDERSTANDING, as now we are 110.000 members worldwide, collaborating without boundaries thanks to the web revolution (111 words)

Seconder: IW Club Torino Europea

Before our meeting the objects presented were: "Service, international understanding with kindness and mutual respect" and after discussion we decided to present: "SERVICE WITH KINDNESS, MUTUAL RESPECT AND INTERNATIONAL UNDERSTANDING"

Comments during our meeting:

- Service without kindness is impossible to realise
- Friendship in IW is sincere in a lot of situations and not in other. Changing friendship in kindness and mutual respect is a revolution.
- Respect and kindness are 2 very important aspects and come before friendship
- Respect and kindness are modern observations, adapted to our today's life. It is very important to reflect these changes and insert them in our Constitution.

For respect we can also use many other explanations as « show curiosity for the views of others, practice transparency, understand others perspectives, have great attention for the views of others.... etc...and this can be used also for the other « two minutes supporters »

As well as for kindness as we can say also kindness is being selfless, caring, compassionate, unconditionally kind

Kindness boosts happiness and optimism

Kindness is a moral elevation, kindness is bringing a sense of meaning to life, or

being kind brings a sense of meaning because it involves investing in something bigger than ourselves etc...etc...

The time of 3 minutes to propose and 2 minutes to comment, support or answer has to be prepared and really used to explain our "revolution".



WORKSHOP B

PROPOSAL B1

Page 4 membership - Naming of a club -

Delete page 8 "subject to the approval of IIW"

Motivation:

Women who create an IW Club are well aware about the importance of the name of the Club. They are the best placed to choose a geographical name taking the historical and cultural identity in mind. Clubs should have the democratic right in choosing the name, without interference of IIW.

Proposer: NGB Belgium-Luxemburg Seconder: Great Britain and Ireland

This proposal of Belgium and Luxemburg had been rejected last time and not inserted in the agenda without any reason. It is a democratic right of the club to choose its name by itself.

The following proposals (B2 to B5) concern e-club, they were read and discussed only after the last one.

PROPOSAL B2

Proposal 1, to amend (C&H 2021 - MEMBERSHIP pag. 4)

e-Clubs

1. At International level

Includes all Inner Wheel Clubs and e-Clubs.

The minimum number of Active Members required to form a Club or an e-Club is 10.

MOTIVATION

New Inner Wheel needs e-Clubs.

They have the same position and targets as normal clubs and pay normal capitation fees. Many the reasons:

Having e-clubs would give IW an enormous boost and might promote IW in another way.

Thanks to the digital possibilities it's a great opportunity to meet members all over the world and promotes international understanding.

Attractive for young busy women, older members who prefer to stay at home in the evenings and a way for MAL's to be in a club.

Meeting by zoom is far more sustainable. (Words 91)

Proposer: Italy Seconder: Germany

PROPOSAL B3

(New article in 4 paragraphs) pag. 7 C&H

e-Club

- 1. A member can serve the Inner Wheel through the electronic model of an «e-Club», meeting exclusively on digital platforms.
- 2. Class of Membership:

Virtual Active Membership.

Virtual active membership may be retained or taken up by women who have been invited to join provided that they are over 18 years, and the majority of the e-Club members agree.



- 3. Applications for virtual active membership shall be sent to the Administrator of International Inner Wheel, together with an agreement to adopt the Guidelines for e-Clubs and to observe the Constitution. This agreement is binding on all e-Clubs.
- 4. A member may belong to one Club and to one or more e-Club simultaneously.

Double membership would support a better launching of e-Clubs: We will have expert members collaborating with new ones, transferring their know-how and skills, and making the new Club immediately operating according to the Inner Wheel governing rules and procedures.

Many Inner Wheel members are also members of Rotary, Soroptimist, as well as of other Club Services or Associations.

So why should we not take a chance to serve the Inner Wheel through e-Clubs, too, thus multiplying the value contributed and, especially, differentiating the mode of working.

A possibility, an important innovation.

Not a «problem», rather an «opportunity». (Words 97)

PROPOSAL B4

e-Club

An e-Club can consist of members who belong to a District, a Country or different geographical areas. The Vice International Inner Wheel President takes care of the e-Clubs, as of new countries and ND Clubs.

MOTIVATION

E-clubs could be a district e-club with members of one or more districts, a country e-club with members from one or more countries. a continent e-club with members from for instance Europe, India or Africa or even a GLOBAL e-club with members from all over the world, from different geographical zones.

Flexibility is the key word here.

Appropriate and clear guidelines are needed to help Interested members to make their choices and create e-clubs that serve their needs and interests.

The purpose is to create more Inner Wheel clubs and e-clubs and the letter could be a unique selling point for IIW.

PROPOSAL B5

new article

Naming an e-Club

When a new Inner Wheel e-Club is formed, the members of the new Club may decide on a suitable name.

The e-Clubs are member of IIW.



As there will be various possible types of e-clubs in future it's advisable to choose an appropriate name but not necessarily one that is linked to its geographical area.

As with women who want to form a regular Inner Wheel club the members of a new Inner Wheel e-club will certainly be aware of the importance of their club's name.

They are surely capable of deciding a suitable name for their club and it is logical That they are the ones who decide on its name.

Proposer: Italy Seconder: Germany

The motivation of B4 read during the meeting was far too long to be written but could be kept to be read by the proposer within the 3 minutes time.

All kind of e-clubs have been discussed. The Constitution Chairman has to write the guidelines for e-clubs, but all the aspects are inside these proposals.

Comments:

- If I belong to an e-club, where do I pay the capitation fee? if I am in different clubs, do I pay different capitations fees?" Answer: you pay a capitation fee in each club.
- If an e-club belongs to a district, it can fall within the organization of the district.
- If, on the other hand, an e-club is national or international, it will be under the tutelage, guidance of IIW.
- E-clubs give to the member the possibility to choose flexibility
- E-clubs could be an advantage in cities.
- The purpose of e-clubs is not to give an extra-boost to a country but to IIW.
- When we spoke of global e-clubs, it means that e-clubs can be realized around the IW world, being national, continental or transcontinental; in other words, they are international e-clubs.

Delete and replace paragraphs in paragraphs 5, 6, 7, 8, 10 and 11

5 President

Α

Delete "from The President, until Inner Wheel Headquarters." Replace with

The President shall be nominated and elected to serve for one year, or more if there is no willing candidate to take office, and providing the club agrees.

If the President of a newly formed club so wishes, she may with the club's agreement, serve for a whole Inner Wheel year in addition to the part which immediately follows the club's formation. Delete B and C

6 Vice President Delete A, B and C



Replace with the Vice President shall be nominated and elected annually and preferably shall not serve for more than 2 consecutive years.

7 Secretary

Delete A B and C

Replace with The Secretary shall be nominated and elected annually and preferably shall not serve for more than 3 consecutive years

8 Treasurer

Delete A B and C

Replace with

Replace with The Treasurer shall be nominated and elected annually and preferably shall not serve for more than 3 consecutive years.

10 Club Correspondent and International Service Organiser

Delete A and B

Replace with

shall be nominated and elected annually and preferably shall not serve for more than 3 consecutive years

11 Other members of the Executive Committee

Delete A and B

Replace with

shall be nominated and elected annually and preferably shall not serve for more than 3 consecutive years

MOTIVATION

This is a matter for the club, and it would be painful if a club were to close because no candidate is available. Permission from District or IIW should not be necessary.

It is really difficult in some countries to find persons who agree to take positions at any level so if the person is doing well at her job and no one is willing to take the position, why a limit on time. This is a club matter, and no permission needs to be asked either to the district or IIW Headquarters.

Proposer:

Seconder:

We should shorten and simplify our Constitution but as it the actual Constitution it is written one by one, we have to keep it in the presentation of our proposal.

We have to move slowly but this would give a kind of "freedom" to the clubs. The term "preferably" is already used in the by-laws of GB & I.

The proposal C1 came out because in a lot of countries we have no candidates for these positions in the club (president, secretary, treasurer....) Many clubs have real difficulties and if a person is doing well her job and nobody wants to take the position why a limit? This is a club matter; no permission has to be asked.

PROPOSAL C2

p.35 – 18. RESIGNATION

At the end of the first phrase add 31st May so that it will be:

A month's notice of resignation must be given in writing to the Secretary before 31st May



It is quite important to state the precise date with regard to such a serious issue. A rule must be as specific as possible. Indeed, if the deadline for submitting one's notice of resignation is clearly established, it stands to reason that there will be no right of objection.

P.34 _ 14. Meetings

Paragraph A and B: insert "preferably"

- a) Meetings of the Executive Committee shall be held as often as necessary and preferably once a month. Special meetings may be called by the President, or when requested by 2 members of the Committee.
- b) Meetings of the Club shall preferably be held as agreed by members. Special meetings may be called by the President, or when requested by not less than 20% of the members. At least a 48-hour notice shall be given.

MOTIVATION

It is important that the meetings can preferably be held according to the wishes of the members of the committee or the members of the club. The more often you meet the more you can exchange and serve

Proposer: Seconder:

PROPOSAL C4

P 34 – 15. Voting A Voting at elections shall be by ballot B, C and D *unchanged* Add:

A Voting at elections can be by ballot or e-voting or sending the vote before the meeting by mail.

MOTIVATION

As international election is now by e-voting, all clubs, all over the world should be allowed to have the choice to proceed by e-voting if they wish so. This possibility has to be given to all clubs as they must be equal, with or without district/NGB.

PROPOSAL C5

Standard rules for clubs P. 30 – 3 Qualifications

Page 30 - 3-Qualifications

"President and Vice President:

Must have served on the Executive Committee for at least 1 year at the date of taking office."

Delete the whole paragraph.



Qualifications required for the offices of President and Vice President can be acquired and demonstrated within and outside Inner Wheel. These skills are not unique to Inner Wheel and should be sufficient for a nomination. The only qualification required is to be an Inner Wheel member for at least one year.

WORKSHOP D

We are not sure that NGB can present proposals concerning a district or not as there is a mistake in the Constitution. Sissel knows it but the constitution was already printed so, it should last till the next Convention.

PROPOSAL D1:

Page 36 NAME

Delete Committee in line one and insert District.

Insert in line five:

The district can choose to add their country to the number of the district.

MOTIVATION:

The headline says Standard rules for districts and this ought to be reflected in the name.

The levels of Inner Wheel are Clubs, Districts, for some countries National association, and International Inner Wheel we have to make the rules simpler and have the same rules all through our organization.

Proposer: Cyprus

Seconder: Begium and Luxemburg

You could put the international codification before the number or the name of the country after it. It would help you know immediately the country of the district.

PROPOSAL D2:

Page36

Insert after 1. NAME a new Point 2 PURPOSE OF THE DISTRICT

-To help, support and inspire the Inner Wheel clubs within their geographic area and to be the link between the clubs, the national organization if such exist, and International Inner Wheel.

-To brand Inner Wheel in their geographic area and establishing new clubs.

MOTIVATION:

It is important that our constitution describes our organization and especially describes the purpose of each level. Inner Wheel is our clubs and from old time the districts, national and international organization was only meant to hold administrative tasks.

In the districts the clubs work together can promote and realize our objects of friendship, personal service, and international understanding. It is reminded that "IIW is the best secret kept in the world" therefore very important to make this proposal to change this.

It is important for the new members to know the purpose of the district.

Officers:
Line one to three
Delete Chairman insert President.

MOTIVATION:

The same office at all three levels ought to have the same name. Club President, District President, and International President. This makes our Constitution and rules more understandable for our members.

It is better to have the same rules at all the levels.

PROPOSAL D4:

Page 43

18. MEETINGS OF THE DISTRICT COMMITTEE

line one delete after ... shall meet at least

insert four times a year, some meetings can be held virtually, and at least one requires physical presence.

1 meeting shall be the annual General Meeting.

MOTIVATION:

Today geographical and climate conditions is no excuse as we have the possibility to use virtual meetings.

Proposer: IWC Salzburg/D 192 Austria & Czech Republic Seconder:

A lot of countries or districts have only one or 2 meetings but with the new virtual possibility, it is much easier to organize more meetings. There is no more excuse such as climate or geographic distance.

WORKSHOP E

It was a very intensive work as we had different kinds of countries with or without NGB and districts. We saw that the work of the NR is completely different.

PROPOSAL E1:

Add a chapter: STANDARD RULES FOR NATIONAL GOVERNING BODIES after page 45

1. Name

The name of the National Governing body shall be the usual name of the territory. Association or National or Council, it will be defined by the National Governing Body



2. Membership

The National Governing Body shall consist of all clubs within its boundaries?

3. Governing Body

a. Officers

i. National President

Chairs the NGB, must visit all the districts at least once a year, is entitled to be a voting member on all Committees at National Level, ensures all trainings... National President and National Vice-President must not be from the same district.

Is elected for one or 2 years If only one candidate: can be elected "election non opposed"

(According to the country: National Representative and President can be one unique person)

ii. Vice-President

Must work with the president.

National President and National Vice-President must not be from the same district.

Is elected for one or 2 years If only one candidate: can be elected "election non opposed"

(According to the country: Deputy National Representative Vice President can be one unique person)

iii. Immediate Past-President

Deputises for the National President and the National Vice-President in their absence.

iv. National Secretary

She closely works with the President and covers all the administrative work. Conducts all correspondence for the National Governing Body. Takes the minutes at National Governing Body meetings. Preferably speaks English.

She is elected for a maximum of 3 years. Re-elected annually. If only one candidate: can be elected "election non opposed"

v. National Treasurer

She must have accounting skills.

She works closely with the president She is responsible for the financial affairs of the National Governing body.

She presents a statement of accounts to the National Governing Body at every National Governing Body Meeting. Presents budgets proposals, settles accounts with the districts for payments due to the National Governing Body and International Inner Wheel.

Makes all payments to International Inner Wheel

She is elected for a maximum of 3 years. Re-elected annually. If only one candidate: can be elected "election non opposed"

b. Ex-officio members:

i. National Web-manager:

She is in charge of the website, the international database, the edition of the directory. Works closely with the Editor-Media Manager

She is elected for a maximum of 3 years. Re-elected annually. If only one candidate: can be elected "election non opposed"

ii. National Editor-Media Manager:

She is in charge of the magazine and all national publications. Works closely with the web-manager for various publications on social network.



She is elected for a maximum of 3 years. Re-elected annually. If only one candidate: can be elected "election non opposed"

A and b are the executive committee of the National Governing Body.

c. Other Members of the National Governing Body:

The district president/chairman of each district. She is the link between the National Governing Bodyl and her District and has to make reports of the National Governing Body to her Districts. She promotes co-operation between the Districts and the National Governing Body.

4. Vacancies:

- a. In case of vacancy of the National Representative or the President the deputy or the vice president shall deputise.
- b. In case of vacancy in any of the other offices, the National Governing Body shall appoint a qualify successor to complete the year.

5. Nominations:

- A. Must have been district president. Nominations shall be made through the district committee and must be sent, in writing mail or post to the National Secretary. Nominations must be received not later than 31st October.
- B. A list of nominees, with a short description of offices held, will be sent by email by the National Secretary. E-voting (advised) has to be made before 15th February. To be eligible to vote, Clubs must have paid Capitation Fees by 31st October. Each Club is entitled to 1 vote.
- C. Results of vote shall be sent to Inner Wheel Headquarters immediately.

6. Meetings

- a. The National Governing Body (the executive committee and the District Commmittee and the District Chairmen) must meet at least 3 times a year (Sept. January and May)
- b. The executive committee of the National Governing Body shall meet the day previous the meeting of the whole National Governing Body.
- c. Thanks to modern ways of communication more meetings can be organized.

7. Finance

- a. The accounting year begins on July 1st and ends on June 30th of the following year.
- b. The accounts of the previous year must be audited and certified by an accounting firm and presented by the Treasurer of the audited year to the National Governing Body + districts presidents during the 1st meeting.

8. Bye Laws

The national Governing Body may draw up national, district and club bye laws, based on IIW constitution, and to be validated by IIW before implantation.

9. Disbandment

If necessary, the proposal of disbandment of the National Governing Body will be submitted in General Assembly, to a secret ballot vote by a majority of 2/3 of the present members of the National Governing Body (Executive committee + district Presidents) with a quorum of 75% of the members. Proxy and mailing vote are not allowed.

Each National Governing Body decides on the status of the National Representative. The National Bye Laws will contain the information concerning her role.



All the countries with National Governing Body should be submitted to the same general rules and there is nothing about National Governing Body in our Constitution, it's a real lack. It must be corrected.

We noticed that there are standard rules for clubs or districts but not standard rules for NGB. A lot of them have their own by-laws but it is important for a country which wants to form a NGB to know the rules.

There are 16 countries with national governing body all over the world. Most of the countries the National president and vice president are at the same time NR or deputy NR. The standard rules don't have to take in consideration the role of the NR in these countries.

In some countries such as Italy, the Netherlands, GB&I, it is not the same person and that's the reason why it should not be incorporated in the rules of the NR. These countries can decide by themselves the role of the NR in their country and if this person is in the NGB or not.

The standard rules for NGB are missing in our Constitution.

A Non districted Club and any District Committee may nominate a suitable qualified member for the office of an UN Representative

-Voting:



The Un IW-Representative are elected during the Governing Body Meeting before the Convention by the whole International Governing Body.

-Tenure of Office:

They are elected for a term of 3 consecutive years from Convention to Convention. They might be reelected for a maximum of 2 Periods total (6 years). They serve from 1st July after a Convention till 30th. June after next Convention.

-Expenses:

Expenses incurred in carrying out the work of their duty shall be refunded up to 1000 Pounds for each UN Inner Wheel -Representatives.

MOTIVATION:

We have a membership of more than 100.00 members and 7 Un-Representatives position in total. In former days, some UN Inner Wheel -Representatives served more than 30 years, other members didn't apply for it not to be unkind to those in the chair. But especially for young women it could be very attractive. It is a very important function; therefore, it should be for a term for 3 years from Convention till Convention. If there is no other nomination, the term can be prolonged for a maximum of 2 times in total (6 years).

This proposal is very important to attract young women who would be very proud to take this position.

As we are not UN delegate but only observers, it has been decided to write "UN-IW Delegates". They are delegates from IW at the UN.

A UN IW delegate must have been IW for at least one year before.

Martine Gayon will be asked how we can be more than an observer, but we must be aware that IIW is an administrative administration and the statutes we have today come from the years 70. If we ask for more, we can lose everything.

UN should be open to any member and not only to those living close to either Vienna, Geneva or New York.

We should know how much time it takes to be UN IW delegate in order to know if young IW members who work could apply for the position.

Some are surprised that the reports they make are not on the website. Martine Gayon communicates a lot through Facebook and Instagram but what about the other delegates.

They all give reports to the IIWVP and years ago these reports were collected in the IIWVP's report. Today these reports are shorter and shorter, not reports but summary of reports.

In Switzerland, they receive the report from the delegate in Geneva, once a year, when the district committee life is over.

The present delegates were nominated by the board. We must find the way to use this information. We have a lot of tools to communicate, understand how we must change.

Our executive is not working enough.

It is appropriate, thanks to the digital technologies also used in Inner Wheel, to organize the Convention in a "hybrid" form. In this way it will be possible to significantly increase the participation of members in the most important event held by International Inner Wheel.

If, for serious reasons, it is not possible to convene the members "in presence", the Convention will have to take place "virtually", as already occurred in the 18th Convention, the first virtual one in Inner Wheel history. (Words 82)

It is considered appropriate, in case the IIW President cannot preside over the Convention, to replace her with the Vice President, or with the Immediate Past President, who are officers of the International Inner Wheel Governing Body in charge, simplifying in this way the procedure. (Words 45)

C&H, Page 27, Standing Orders

Insert a new point 19

19. A proposal can be withdrawn only if the proposing and seconding Clubs, Districts, NGBs have discussed and agreed about this withdrawal.

MOTIVATION

This is a crucial point, which concerns the withdrawal of a proposal.

It is established that:

The withdrawal can be accepted only if the proposing Club, District, NGB and the seconding Club, District, NGB have discussed and voted on it in their respective Assemblies and "agree" to withdraw the proposal.

Otherwise, the proposal lives on and will be submitted to a vote during the Business Session of the Convention.

What has matured in the agreement cannot be dissolved only by a Club, District, NGB, whether proposing or seconding it. (Words 102)

If clubs worked together to write a proposal it is logical to discuss together to cancel or withdraw a proposal. This possibility must be given if the 2 parties agree.

Insert after ...International Inner Wheel by the required date.

No proposal can be submitted without having been discussed and approved in an IIW GB Meeting, NGB Meeting, District Meeting or Club Meeting. A copy of the page of the minutes, related to the proposal, should be sent to IIW Headquarters, and be published at the website together with the proposal.

MOTIVATION

There are two basic steps to follow before submitting a proposal to change the Constitution. First, the proposal must be discussed and approved by the Assembly at every level; IIW Governing Body; National Governing Body; District Committee; Club. Therefore, this approval will be documented by the extract of the Minutes certifying the approval, which will be sent to the Headquarters together with the proposal. In this way any wrong procedures, not respectful of the sovereignty of the Assembly of each Governing Body, will be avoided. (Words 85)
